**THE BOARD OF EDUCATION OF Toms River**, located at  
1144 Hooper Ave., Toms River, NJ 08753 (hereinafter referred to as the "Board"  
or "District") \_\_\_\_\_,

And

**Dr. Stephen Genco** hereinafter referred to as "Dr. Genco " or " Educational Leadership  
Consultant "), who together at times may be referred to as "the parties".

**WITNESS THAT:**

The Board and Dr. Genco agree and acknowledge the following:

- A. The Board of Education of the Toms River School District is a corporate body politic governed by N.J.S.A. 18A:1-1 et seq.
- B. The Board continues to be in need of services of an Educational Leadership Consultant for transition purposes, pending further action by the Board.
- C. The Board wishes to employ Dr. Genco as Educational Leadership Consultant for the period commencing May 1, 2022 and continuing through and until Dec. 31, 2022, subject to the terms and conditions set forth herein.
- D. Dr. Genco desires to accept such additional employment and does hereby accept such employment as Educational Leadership Consultant as outlined above in accordance with the terms and conditions hereinafter set forth, which terms and conditions the Board and the Educational Leadership Consultant believe and intend to be consistent with the requirements of N.J.S.A. 18A:1-1 et seq. and applicable sections of N.J.A.C. 6A:1-1 et seq.
- E. The Board and Dr. Genco intend to contract with one another for the services of Educational Leadership Consultant and are bound in accordance with the terms of this Employment Contract and the provisions of the statutes and rules and regulations of the State Board of Education and the Commissioner, if any.

**NOW, THEREFORE**, in consideration of the above stated acknowledgments and of the mutual terms, promises and covenants contained herein, the parties agree as follows:

1. Term. The term of employment as Educational Leadership Consultant shall commence on May 1, 2022, (hereinafter "Effective Date") and continue through and until Dec. 31, 2022, unless sooner terminated by the parties as set forth herein.

2. Duties.

A. Dr. Genco agrees to perform the duties of Educational Leadership Consultant as such duties are prescribed by the laws of the State of New Jersey and the State Board of Education and the rules, policies and regulations of the Board and in accordance with any amendments to any said statutes or rules, policies and regulations that may become effective during the term of this Contract.

B. All duties assigned to the Educational Leadership Consultant as requested by the Superintendent or Board President shall be appropriate to and consistent with the professional role and responsibility of the Educational Leadership Consultant and shall be in accordance with Board policy and intended for a smooth transition for the new Permanent Superintendent of Schools.

3. Compensation.

A. Salary: During the term of this Agreement, on days that either the Board President or Superintendent request his services the Board agrees to compensate Dr. Genco at the per diem rate of six hundred dollars (\$600.00) per day pursuant to the District's school calendar payable consistent with the District's regular payroll periods. Dr. Genco shall be paid through the District payroll. Dr. Genco shall be paid \$300.00 a day on days he performs services up to four (4) hours and \$600.00 a day on days he perform services in excess of four (4) hours. There is not a mandatory minimum number of days that the Board is obligated to pay Dr. Genco. There is not a maximum number of days that Dr. Genco will be asked to perform services. The Board will pay Dr. Genco only for days he worked.

B. Fringe Benefits: During the term of this Agreement, the Educational Leadership Consultant shall be entitled to the following benefits:

a) Dr. Genco shall not be entitled to health insurance benefits or personal days off with pay.

b) Mileage Reimbursement: Dr. Genco shall be reimbursed for required use of his personal vehicle during school business, pursuant to the State OMB rate. Dr. Genco shall also be eligible for reimbursement for required expenses consistent with Board Policy upon submission and approval of vouchers.

c) No Additional Benefits. The Educational Leadership Consultant shall be entitled to no additional benefits for his service as Educational Leadership Consultant.

4. Termination of Interim Superintendent Contract.

- A. This contract shall terminate Dr. Genco's employment as Interim Superintendent on the Effective Date. shall cease, and no additional compensation shall thereafter be paid, under anyone of the following circumstances:
- 1) Revocation or suspension of the Educational Consultant's certificate(s);
  - 2) Forfeiture under N.J.S.A.2C:51-2;
  - 3) Mutual agreement of the parties;
  - 4) Upon the giving of thirty (30) calendar days advance written notice of termination by either party to the other party for any reason whatsoever.
- B. The Parties agree that this Contract serves as notice of the termination of Dr. Genco's contract as Interim Superintendent.
- C. Nothing in this Contract shall affect the Board's rights with regard to suspension under N.J.S.A.18A: 6-8.3 and applicable case law.

5. Conflicts. In the event of any conflict between the terms, conditions and provisions of this Employment Contract and the provisions of the Board's policies, or any permissive State or Federal law, then unless prohibited by law, the terms of this Employment Contract shall control over the contrary provisions of the Board's policies or any permissive law during the term of the Contract.

6. Severability. It is the intention of the parties that the terms and conditions of this Contract shall be consistent and in full compliance with the provisions of N.J.S.A. 18A:1-1, et seq., the laws of the State of New Jersey and the rules and regulations of the New Jersey Department of Education. This Contract shall be construed accordingly. If any provision of this Contract is determined by any court or reviewing agency to be invalid or inconsistent with the law, it is the intention of the parties that all valid provisions which are severable from the invalid provisions shall remain in effect and that this Contract shall continue to be effective to the full extent that it is consistent with the law.

7, **VOLUNTARY TERMINATION.** Dr. Genco may terminate his employment giving the Board of Education at least thirty (30) days written notice.

8. **CONTROLLING LAW** This agreement shall be governed by the laws of the State of New Jersey.

7. Amendments. No amendments or additions to this Contract shall be binding upon the parties unless in writing and signed by both parties.

8. Entire Agreement. This Contract contains the entire understanding of the parties and there are no representations, warranties, covenants, promises or undertakings other than those expressly set forth herein. This Contract is intended to be binding on the successors, assigns and legal representatives of the parties hereto.

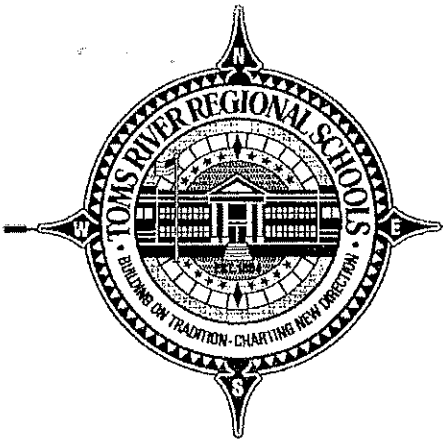
