- 3. Demonstrated language proficiency and knowledge of effective teaching methods.
- 4. Ability to maintain a positive learning environment.
- 5. Strong interpersonal and communication skills.
- 6. Required criminal history check and proof of U.S. citizenship or resident alien status.

REPORTS TO: Superintendent/Assistant Superintendent/Principal/Designated Administrator

**JOB GOAL:**

To provide an approved bilingual education program that fosters English proficiency, academic learning and personal growth.

**PERFORMANCE RESPONSIBILITIES:**

- 1. Curriculum and Lesson Plans
- 2. Plan, organize, and provide instruction in English and in the native language of students in the appropriate grade level content area standards. Instruction shall be closely related to and coordinated with the regular instructional program so that students meet and exceed the standards.
- 3. Plan, organize and provide instruction to assist students in mastering verbal and written skills in English, as appropriate, coordinated with instruction in the required English as a Second Language Program with the goal to exit students into the regular education program.
- 4. Plan, organize and provide instruction in verbal and written skills of the native language.
- 5. Provide instruction and experiences in learning the history and culture of America and the community. Provide instruction and experiences in learning the history and culture of the native region and/or country of the parents.
- 6. Develops lesson plans and instructional materials and provides opportunities for individualized and small group instruction in order to adapt the curriculum to the needs of each pupil.

**Classroom Activities and Work with Students**

- 1. Participates in the assessment of the English proficiency of pupils whose native language is other than English; helps to identify pupils eligible for bilingual education and/or English as a Second Language programs or other services designed to improve English language proficiency.
- 2. Assesses pupil academic progress, English proficiency and personal growth toward stated objectives of instruction. Assesses annually to determine pupils ready to exit the bilingual/ESL program.
- 3. Maintains records of pupils' educational progress in class record books and/or approved forms and summarizes these marks for reporting purposes.
- 4. Identifies academic and support services needs to limited English proficient pupils and cooperates with other professional staff members in assessing and resolving learning problems.
- 5. Establishes and maintains standards of pupil behavior needed to achieve a classroom climate conducive to learning.
- 6. Budgets class time effectively.
- 7. Devises written and oral assignments and tests that require analytical and critical thinking as well as the reproduction of facts.
- 8. Supervises pupils in out-of-classroom activities as assigned.

### **Maintains Good Relations with Parents**

1. Communicates with parents through conferences and other means to inform them about the school program, discuss pupil progress and encourage their involvement in the development and review of program objectives.
2. Works cooperatively with the district's bilingual parent advisory committee.

### **Other**

1. Maintains professional competence and continuous improvement through in-service education and other professional growth activities.
2. Participates in school-level planning, faculty meetings/committees and other school system groups.
3. Makes effective use of community resources to enhance the instructional program.
4. Upholds and enforces school rules, administrative regulations and board policy.
5. Notifies the school principal promptly with information relevant to orderly district operations, such as observations about gang activity, signs of student depression, or signs of child abuse.
6. Performs other duties as may be assigned by the superintendent or his/her designee within the scope of employment and certification.
